



ACQNOWLEDGEMENT CONSENT TO PARTICIPATE BILLABONG STATION

I, the undersigned hereby consent to my child, the above named, to participate in the Billabong Station Day Program at Sages Cottage Farm. In the event of an accident or emergency, I authorize the staff and agents of Billabong Station to obtain for my child all necessary medical and dental assistance and treatment as may be required as well as administer First Aid. I give my permission for my child/ren to be released in to the care of a medical practitioner or any other medical personnel as deemed necessary. I agree to reimburse Menzies Inc. and pay all the expenses incurred in relation to such assistance and treatment.

I hereby release to the full extent permitted by law Menzies Inc. and Sages Cottage Farm and their employees and agents from all claims and demands of every kind for any accident harm or loss for which my child may suffer or that I may suffer as a result of my child participating in the school holiday program. I hereby indemnify Menzies Inc. and its staff and agents to the full extent permitted by law for any loss, damages, expenses, claims, actions and suits brought for and on behalf of my child and arising out of or in any way connected to Billabong Station at Sages Cottage Farm.

I understand that staff do not supervise my child/children until they are signed in to the program by a parent/guardian. Neither are they supervised after they have been signed out of the program by a parent/guardian. I also acknowledge that there is a late pick-up fee of \$5 per minute which I will be responsible for paying.

I understand that the Sages Cottage Farm Billabong Station school holiday program does not open until 10 am and I can not sign my child/ren in until then. I accept full responsibility for my child's belongings whilst attending the program. I undertake to inform the program staff of any absence of my child. I acknowledge that my child will not attend the program if suffering from an infectious or contagious disease. In the event that my child is injured or becomes ill during the program, either an authorised person or I shall collect the child as soon as practical. I give permission for my child/ren to participate in program-based activities organized for the days my child will be attending. Menzies Inc. does not accept any liability for personal injury, property damage or loss sustained by any participants as a result of her participation in Billabong Station School Holiday Program due to any cause whatsoever. I certify that the information provided on the enrolment form is correct at the time of completion. I have read the regulations and agree to abide by the policies contained therein. I fully understand that if my child continuously misbehaves after behaviour guidance procedures have been followed, I will be notified and my child may be removed from the program.

I declare that my child is in good health and is fully able to participate in the Billabong Station School Holiday Program at Sages Cottage Farm.
