President's Report

In preparing to write the 149th President's Report for Menzies Inc. I found myself once again reading "One Thousand White Onions: A History of Caring for Children from 1865" by our much loved historian Shirley Davies. Reflecting on my first year as President, it reminded me that Menzies and its preceding ten organisations have never been defined by conservatism but rather by an agility to respond to change and meet challenge secure in the strong foundations of courage and persistence.

In the book's foreword, Professor Dorothy Scott wrote,

"Each generation of child welfare reformers responds to the challenges of the time with the knowledge and resources that are available. We have knowledge and resources of which earlier generations of child welfare reformers could not have dreamed. This places upon us a greater responsibility, for it is the gap between what we know and what we do by which we will be judged by history."

This year has been a remarkable year in Menzies' history and has called on all of us - staff, the Committee of Management, members and our children and young people and their families - to be courageous and agile.

On 11 February 2014 we made the announcement, first to staff, then to young people and their families and other important stakeholders in the days following, of our plans to evolve from a residential care organisation to a grant making organisation in Frankston and on the Mornington Peninsula.

These changes began as a result of the review of operations that Phil Jones, immediate past President, described in last year's annual report. As a Committee of Management we looked to the future and realised the support and compliance requirements for young people in care are increasing in complexity and smaller organisations like Menzies, operating in a fragile funding environment, had limited opportunities for growth.

Following this announcement, Menzies worked closely with the Department of Human Services (DHS) in an effort to provide continuity of care for the young people in the four Menzies homes. In April, DHS announced that that the homes would be shared among four experienced and suitably qualified providers being Berry Street, Anglicare, Wesley Mission and Mackillop Family Services. The handover to the new providers was completed on 30 June 2014.

During the year we also entered an agreement with Wallara to take over the management of Sages Cottage. We were delighted to have entered an arrangement with an organisation that strives to support people to live the life they choose in a world where there are no barriers for people with disability. Wallara was identified by an expression of interest process that was endorsed and supported by local member The Hon. Bruce Billson MP. I have no doubt that the future development of Sages will be exciting under the leadership of Wallara's Chair David Willersdorf and CEO Phil Hayes Brown and their Board.

My words here will never express the great admiration and respect I have for the Menzies team at this time of change and uncertainty. The team, led by Jacinta Larkins and Mary Beth Melton, together with Jacinta Dunn, was professional, understanding, and committed throughout the transition process. A special thank you to the residential workers who continued to care for the young people and uphold their welfare at a time that was personally and professionally difficult for all. This is what I admire most and on behalf of Menzies, "Thank you!"

Shirley Davies' work and passion for Menzies goes far beyond her enduring legacy captured in the pages of our history, "One Thousand White Onions". Shirley has been responsible for helping many people find the missing pieces of their life's jigsaw. The care she has taken in documenting and archiving documents, articles and photos is priceless and will continue to touch many people's lives and their families. Shirley a heartfelt, "Thank you".

Menzies Home Association remains a valued part of Menzies. I would like to thank Rick Hodges and Ray Fordham and look forward to continuing this relationship as Menzies writes this new chapter in its history.

I would also like to thank our members and supporters who are listed in this report. Your involvement and interest are very important to our future and the future vision we have, to make a difference in young people's lives.

I am very privileged to work with members of the Committee of Management and even more so at this time of change. I would like to thank my Vice President Greg Lacey, Treasurer Mike Tonroe and members of the Committee Denis Hildebrand, Kevin Johnson, Anne Ridgeway and Alan Splatt for their unwavering commitment, hard work and dedication.

We all lead incredibly busy lives and your preparedness to give up your time willingly is a testament to you as people and your commitment to making a better world for these young people.

In the coming year we will work towards liquidating our assets and set up a fund that will allow us to support projects that focus on the needs of children and young people in Frankston and the Mornington Peninsula who are in out of home care, at risk of being in out of home care or transitioning from out of home care. We will be seeking community input to ensure that our decision making is robust and we will present the findings and our plan in 2015.

In closing I would like to quote again from Professor Scott's foreword,

"Menzies is one of the very few welfare agencies which has retained residential care as a core part of the services offered to children in need of care. The depth of its expertise and its continuing commitment to innovation mean that the Home on the Hill may well become the light on the hill for the rest of the child welfare field."

The Committee is mindful of the legacy of Menzies and will continue to work thoughtfully yet courageously and with agility, so we position ourselves to work with and through others to be the light on the hill for children and young people in Frankston and on the Mornington Peninsula.

I feel deeply honoured to represent the Menzies Inc. Committee of Management as its twenty first president and I am delighted to present you this year's Annual Report.

The major source of grant funding in the 2014 financial year was \$3.2 million from the Department of Human Services (DHS). This was applied exclusively to funding out of home residential care for Menzies' young people across four properties.

Menzies transferred its residential care services to DHS on 30 June 2014. The net result for the year was a loss of \$228,065 (2013 was a surplus of \$182,126). The result included extraordinary costs associated with transfer of services: staff redundancy costs of \$233k and the cost of assets donated along with transferred houses of \$53k.

Ignoring extraordinary items associated with the transfer of residential care services, Menzies completed the year \$96k ahead of budget for the year. This was a good result considering the changes made leading up to the June 2014 handover to DHS partnering agencies. Jacinta Larkins and her team maintained excellent management and control over costs whilst continuing to provide high quality professional services for our young people in care.

Menzies goes into the 2015 financial year with a strong balance sheet with net assets of \$5,468,513. This includes \$818,931 of net current assets after settling all of its obligations for staff entitlements.

Your Committee of Management is confident Menzies has sufficient financial resources to fund meaningful projects that will continue to have positive impact on the lives of young people in Frankston and the Mornington Peninsula.

CEO's Report

No organisation can be successful without adapting to the changing needs of its stakeholders over time. For 149 years Menzies has grown and developed always striving to offer the most appropriate service for marginalised young people. Big changes occurred in the early 1900s it transferred from Melbourne to Frankston where it established the "Home on the hill" then in the 1960s when in response to new models of care, the home was sold to establish family group homes.

The time for significant restructure has again come around and on the 11th February 2014 the Committee of Management announced their decision to cease being a residential service provider.

On the 30th June 2014 Menzies transitioned the operation of its four homes and the young people who live in them to four larger organisations. This was a difficult time and I thank all the residential carers, supervisors, case managers and the Operations Manager, Mary Beth Melton, for the professional and caring way they operated throughout the period of change. I am especially grateful to those residential employees who remained until the 30th June, providing a smooth a transition to the new organisations.

We had our final group of trainees complete their Certificate IV in Child, Youth and family Intervention before closing the Menzies RTO.

The administration team worked hard supporting the residential team in the finalisation of the transfer of the homes and then began the process of winding up their own functions by the end of July. They did so in a very professional manner and I know they'll be welcomed by future employers.

I would also like to thank Shirley Davies' for over 30 years of work at Menzies first as an employee then as the volunteer archivist. Shirley also finished at the end of July.

Finishing a cycle is never without pain and I'm sure those workers at the Home on the Hill were very sad to see it close in the 1960s but Menzies continued to positively impact on the young people who needed them. So it is now in 2014; new organisations are continuing the residential support, Sages is still providing a rural environment to programs run by Wallara, and Menzies will continue to serve its stakeholders in the best way possible.

To the Menzies Home Association members thankyou for your support during my 19 months as Project CEO and your support and encouragement of all the staff during the past year of change.

Finally to the Committee of Management and the Menzies organisation I wish you all the best as you forge a new direction for Menzies.

We are thankful for the fine contribution that Ken made to the welfare of the children in our care and to the vitality of the Menzies Homes for Children.


